




Value of Mining Equity Capital Raised 5-Year (2011 to 2015) Total = \$97 billion




Global Mining Equity Financing 2015 (C\$B)






Diversity in Issuer Base

TSX Venture Exchange and Santiago Stock Exchange

- Agreement signed between TSX Venture Exchange and Santiago Stock Exchange in March 2014
- Dual listing of mining exploration companies, one registration process allows presence in both Canada and Chile
- The secondary market will operate independently from both exchanges
- Participation in MILA Latin American Integrated Market (Mexico Peru, Chile and Colombia)
- Strong alternative to finance mining exploration companies
- Research departments at brokerage firms with analysts specialized in mining


